5. Registration of entrants for single entrance exam and single professional entrance exam, the order of their organization and conduct are carried out in accordance with the Procedure for organizing and conducting entrance examinations conducted using organizational-technological processes of external independent evaluation to enter the second (Master's) level of higher education, approved by the Order of the Ministry of Education and Science of Ukraine dated April 5, 2019 No. 441, registered with the Ministry of Justice of Ukraine on April 26, 2019 under No. 446/33417.

Test tasks of single entrance exam in foreign languages are concluded in accordance with the programme of single entrance exam in foreign languages for admission to study for Master's Degree based on a higher education degree (educational-qualification level of Specialist), approved by the Ministry of Education and Science of Ukraine.

Test tasks of single professional entrance test are concluded in accordance with the programmes approved by the Ministry of Education and Science of Ukraine.

6. For admission to study for Master's Degree on the basis of Bachelor's Degree, the Admission Rules set additional deadlines for applications and documents, competitive selection and enrollment at the expense of individuals and legal entities from September 1 to November 30. The results of single professional entrance examination and/or single entrance exam (including a specially organized session of single entrance exam) obtained in accordance with these Rules and Terms of Admission, or the results of the professional entrance exam and/or entrance exam in a foreign language in a higher educational institution in the cases provided by these Terms.

7. For those categories of entrants for whom the deadlines for applications and documents, competitive selection and enrollment are not set in Items 1-6 of this Section, these deadlines are determined by these Admission Rules. In this case, enrollment by state order ends no later than September 15, except as provided in Sections XIII, XIV of the Terms of Admission. Enrollment at the expense of individuals and/or legal entities ends no later than November 30. Registration and work of entrants' electronic cabinets ends on September 30.

8. State Institution "Luhansk Taras Shevchenko National University" provides for an additional set of entrants at the expense of individuals and/or legal entities on a Full-time mode to obtain Bachelor's Degree on the basis of a complete general secondary education of Junior Specialist, professional degree of Professional Junior Bachelor, educational degree of Junior Bachelor provided that such entrants are enrolled by September 30.

9 State Institution "Luhansk Taras Shevchenko National University" in the Admission Rules may provide for the enrollment of entrants at the expense of individuals and/or legal entities to obtain Master's Degree on the basis of Master's Degree (educational-qualification level of Specialist) in several stages (including the date of admission) subject to enrollment of such entrants by November 30.

The results of single professional entrance exam and/or single entrance exam (including a specially organized session of single entrance exam) obtained in accordance with Item 4-5 of this Section or the results of the professional entrance exam and/or entrance exam in a foreign language drawn up at State Institution "Luhansk Taras Shevchenko National University" shall be used in cases provided by these Rules and Terms of Admission.
